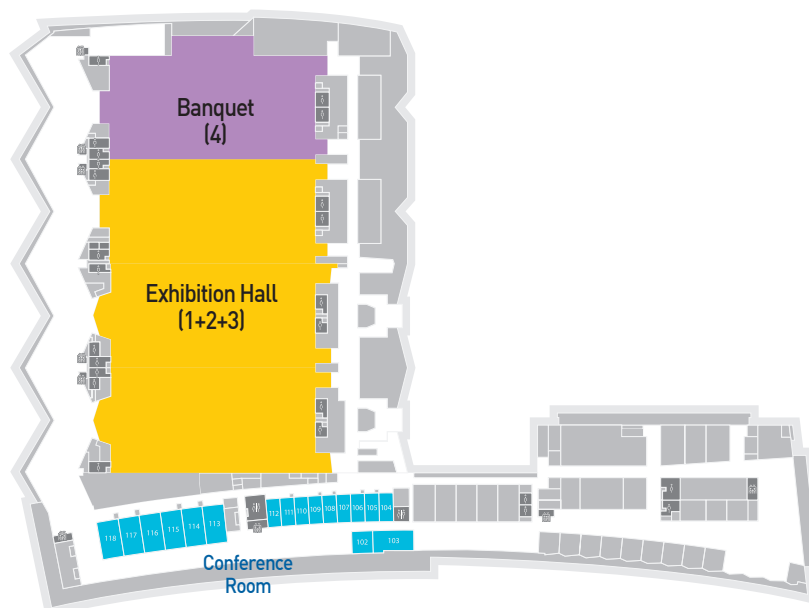

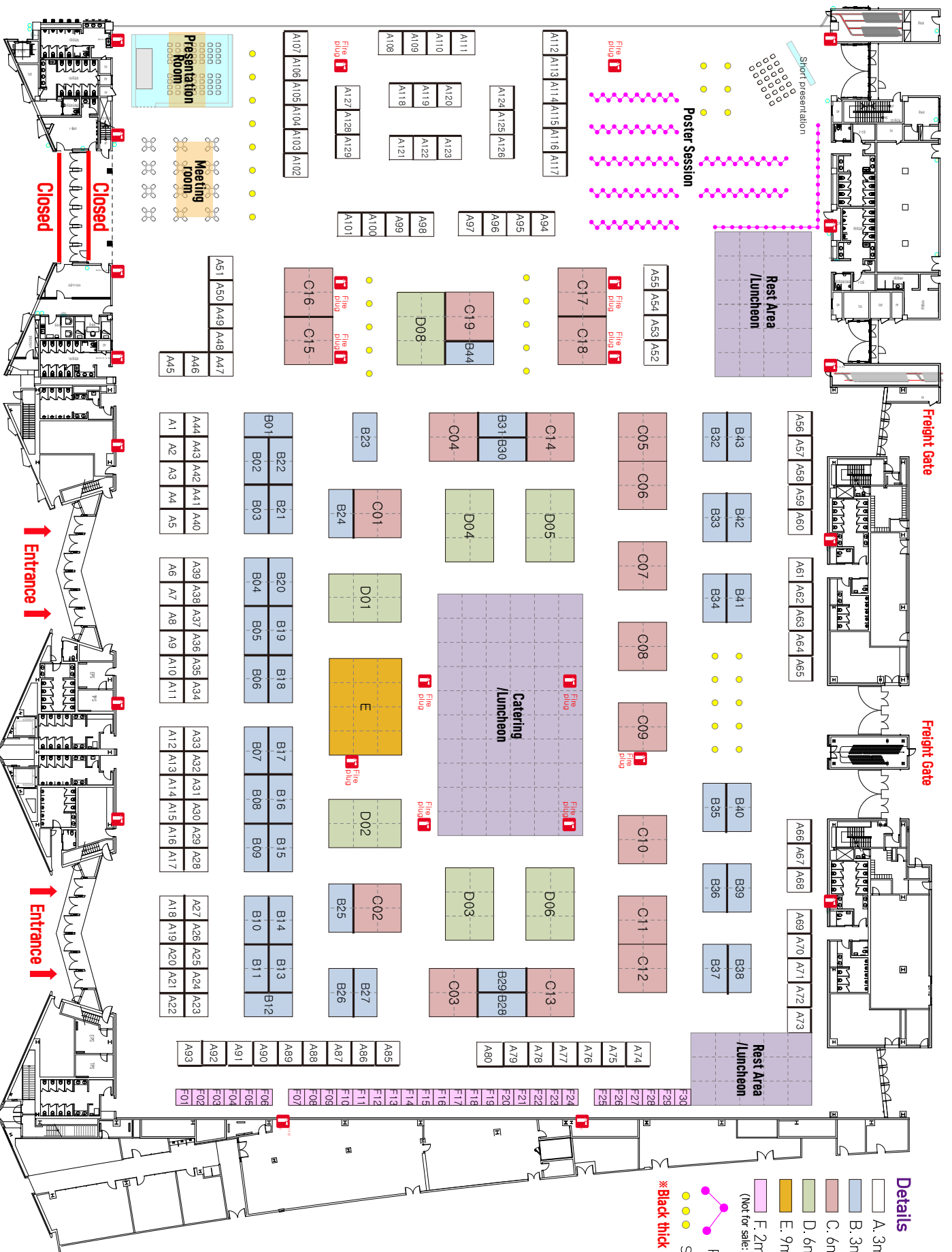
Booth Fees include:
